 FY25 Port Host Community Grant – 1040 Virginia Ave. – Mr. Donahue provided an update on the FY25 Port Host Community Revitalization Grant application submitted on behalf of the Norfolk Portsmouth Beltline Railroad. This application was presented to the Portsmouth City Council at its September 24, 2024 meeting for final authorization. The City Council approved the submission of the application to the Commonwealth of Virginia and the application was submitted on October 3, 2024. FY25 Port Host Community Grant applications are currently under review with the state.

The EVRIFA consists of Hampton Roads member localities. Portsmouth has not yet joined the EVRIFA but wishes to do so. The Authority generates financial support for economic development projects throughout the region. The EVRIFA allows for municipalities to support their neighboring localities through participation in the funding of infrastructure improvements and projects. Participating member localities may share in the revenue generated by the projects. The City Council will discuss Portsmouth joining the EVRIFA.
